RELATING TO THE MAIN FEATURES OF THE ANIMATION
AGREEMENT REGARDING THE SOCIETE DE REALISATIONS
MECANIQUES (SRM) SHARES
(French version only available)

Under Dahir providing Law 1-93-211, of September 21st 1993, amended and supplemented by Laws 34-96, 29-00, 52-01 and 45-06 relating to the Stock Exchange, and in particular Article 7 a,

Considering provisions of the Stock Exchange General Rules, approved by Ministerial Order n°1268-08 of July 07th 2008, issued by the Ministry of Economy and Finance modified and supplemented by Ministerial Order n°1156-10 of April 07th 2010, and namely Article 3.1.9.,

Considering the main features of the animation agreement regarding the LA SOCIETE DE REALISATIONS MECANQUIES shares, signed on October 01st 2011 between the brokerage firm "INTEGRA BOURSE", SOCIETE DE REALISATIONS MECANIQUES and GROUPE PREMIUM.

ARTICLE 1

The brokerage firm INTEGRA BOURSE must offer to purchase and to sale the minimal fixed quantity of securities, periodically updated and published in a notice by the Casablanca Stock Exchange. This quantity can not be less than 25,000 MAD / last reference price.

The said minimal quantity must be offered at prices included within a determined maximal price range, periodically updated and published in a notice by the Casablanca Stock Exchange. This price range can not exceed 4% compared to the reference price authorized by the Casablanca Stock Exchange (upper limit/ lower limit <or =1.04)

The brokerage firm INTEGRA BOURSE must ensure at least a daily frequency of quotation to the fixed security, periodically updated and published in a notice by the Casablanca Stock Exchange.

ARTICLE 2

- The validity of this contract : 2 years
- Contribution in number of shares : 2, 000 SRM shares;
- Contribution in cash : 1, 000, 000 MAD;
- Effective date of this contract : October 13th 2011.
